Sealed quotations are hereby invited from the reputed and reliable agencies/ firms alongwith scope of works and terms and conditions for structural audit for evaluating the structural integrity, stability, and safety of the British Infantry Buildings would involve a comprehensive inspection of the building's physical structure to ensure that they comply with safety standards and regulations (Bldg Nos BI- 1, BI-2, BI-3, BI-11, T-1, T-2, T-3, BI-56, SA-1 to 5) at Army Public School Barrackpore, North Gate, Barrackpore Cantonment , Kolkata-120 under the term & conditions quoted at Para 3 below.

2. Scope of works. As per Para 1 above.

3. Terms & Conditions: -

(a) Tender should be addressed to the Presiding Officer, Army Public School Barrackpore and dropped in the Tender Box of Army Public School Barrackpore (Kept at HQ 122 Inf Bde, AAG office) and in School website.

(b) The envelope containing tenders should be clearly marked as “**Tender for structural audit of British Infantry Buildings (Bldg Nos BI- 1, BI-2, BI-3, BI-11, T-1, T-2, T-3, BI-56, SA-1 to 5) at Army Public School Barrackpore**”.

(c) Amount should be quoted including all costs, other charges, taxes etc as applicable.

(d) Interested bidders may visit the School during any working day between 0830 hrs to 1500 hrs for sample and clarifications.

(e) Last date of submission of tender is 24 Dec 2024 by 1200 hrs.

(f) Tender will be opened on 24 Dec 2024 at 1300 hrs in the Principal’s office of Army Public School Barrackpore. The bidders may remain present at the time of opening of the Tender.

(g) The authority reserves the right to cancel / reject any or all the tenders without assigning any reason whatsoever.

(h) The authority is not bound to accept the lowest tender. Right quality at the right price will be the main consideration.

(j) No payment shall be made in advance nor shall any loan from any bank or financial institute be recommended.
